By my signature below I acknowledge that I fully understand the dangers and risks involved in participating in the training that I have chosen to attend, and that I accept those risks.

As part of my considerations for participating in training with Helen Nicholls of No Monkey Business Dog Training, I agree to hold the instructor and/or assistant harmless and indemnify them from any claims of loss, damage, or injury that may occur to myself, my dog(s), or anyone else participating in or near the session at my request, while on the property of the business, within my home property, or in the general public.

While Helen Nicholls of No Monkey Business Dog Training shall make all reasonable efforts to safely contain the dog during the session, it is understood and agreed that in the event that the dog escapes from its owner, the instructor shall not be responsible or liable for any loss or damage resulting there from, including but not limited to, any loss or injury to the dog.

In addition, I personally accept complete responsibility and liability for any such claim involving myself, my dog(s) and anyone attending the session at my request. I also personally assume responsibility for any negligence or damage caused by myself, my dog, or anyone attending the session at my request.

I am aware that there are inherent risks and hazards involved in activities with and around dogs, and I am voluntarily participating in these activities with knowledge of potential dangers. I am aware that any dog, regardless of training, handling, or environmental circumstance, is capable of biting and I expressly acknowledge the risks therein.

By my signature below I also acknowledge that my dog(s) behavior now and in the future is solely my responsibility. Should any behavior on my dog(s) part now or in the future result in damage to myself, my property, family, children or the property, owners, children, or person of a third party, I agree to assume full liability for any and all such damage, and to absolve Helen Nicholls of No Monkey Business Dog Training from any and all obligations to pay such damage.

By signing below I also indicate my irrevocable consent to the use and/or publication by No Monkey Business Dog Training, LLC of any video(s) or photograph(s) and all photographic negatives, prints, stills electronic media or reproductions provided by me or my family members or taken by No Monkey Business Dog Training, LLC of my dogs.
